COURSE ENROLMENT TERMS & CONDITIONS

REGISTRATION

1.1. Any questions concerning the course structure, content, delivery, and any industry related questions, must be addressed via email at info@themedicinewheel.com.au prior to registration, by way of payment of the course. By proceeding to checkout you are agreeing to make an informed decision about the course based on your independent research and any details about the course provided through correspondence with the teacher.

CERTIFICATION

2.1 All knowledge and skills that are attained from your participation in the course are limited to personal use, until you have successfully completed the course requirements, and have been awarded a certificate of completion, registered for professional practice with the *International Institute of Complementary Therapists* (IICT) and insured through their affiliate broker. A level of proficiency must be met in order to be issued a Certificate of Completion.

2.2 Any missed class time or days will need to be fulfilled in order for a certificate to be issued. If 2 of the 3 days is missed, you will forfeit the amount paid for the course. If 1 day of the 3 days is missed you may have the opportunity to register for the next scheduled (equivalent) date at a charge of \$285. If you have missed less than half a day, you have the option to make up the lost time through a private training with the teacher at the amount of \$80 per hour for each hour missed.

SUPERVISED TRAINING

3.1 It is a requirement of completion to offer 2 members of the public, a 1-hour *Whole Body Massage* each, to be supervised by the teacher. The 2 sessions will be offered on the last day of the course. Students will be asked to bring family members or friends to complete the supervised training.

COMMUNICATION & CONDUCT

4.1 Any concerns or clarifications required during the undertaking of the *Whole Body Massage Course* needs to be promptly addressed via email so as to give Mylène Koury full opportunity to address any issues raised.

4.2 Any course exercises or material that feel too challenging must be expressed immediately to give the teacher the opportunity to address the issue with care.

4.3 The Student understands that any cases of inappropriate behaviour or misconduct towards any and all persons involved in this course could result in early expulsion without refund.
