REGISTRATION

CERTIFICATION

2.1 All knowledge and skills that are attained from your participation in the course will be limited to personal use until which time you have successfully completed the course requirements, and able to demonstrate a certain level of proficiency. Upon satisfactory completion of the course, you will be awarded a certificate of completion in order to register as a member practitioner with the International Institute of Complementary Therapists (IICT). ATTENDANCE

Level 1: 4-Day Foundational Course

Students will be required to attend the full 30 hours of the course in order to be

Level 2: Practitioner 250 hour Course

For each day missed students will be charged of \$300 for an 8 hour training day. For each hour missed amount of \$40 per hour for each hour missed.
